DISTRICT 120 REPORT

Resolution to Transfer from the O&M Fund to the Debt Service Fund

Andy Searle, chief school business official, reviewed the request for the resolution to transfer from the operations and maintenance fund to the debt service fund. The funds will be utilized to pay the debt service on the district's outstanding debt certificates.

Resolution of Intent to Issue \$50,000.000 in Funding Bonds

Mr. Searle reviewed the request to approve the resolution to issue \$50,000,000 in funding bonds to pay off the debt certificates. He shared that this is the first legal step in the process.

School Start Time Proposal

Dr. Anthony Kroll, principal, reviewed the recommendation for the bell schedule proposal for Mundelein High School to have a new start time in SY2022-2023. Discussion was held on the topic.

Technology Update

Dan Crowe, director of technology, reviewed the technology improvements that have been made to support the district's technology plan.
