## **QUESTIONS AND ANSWERS**

Dan Crowe, director of technology, stated that Mundelein High School District 120 participate(s) in the federal E-rate program. This program provides significant discounts on our Internet and network infrastructure. To qualify for this program, we are required to adhere to the Child Internet Protection Act, CIPA, which includes teaching internet safety and to have Internet protection software in place to block access to harmful images. The district does both of these.

The district is also required to acknowledge this in a public meeting such as this and to answer any questions or concerns about Internet Safety.

Mr. Crowe shared that the Board of Education had previously adopted a board policy on internet safety. However, the district considered it was an appropriate time to revisit the policy and would like to continue revisiting every few years.

He also shared that internet safety is taught in Freshman advisory and is reviewed in the physical education (PE) classes, in all grades every school year. Appropriate internet behaviors are also included in the student handbook. Discussion was held on the topic.
