CITIZENS' COMMENTS

DISTRICT 120 REPORT

Adoption of FY2019-20 Amended Budget

Andy Searle, chief school business official, reviewed the recommendations for the adoption of the FY2019-2020 amended budget.

Federal Grant Application Process

Jamie DiCarlo, assistant superintendent of student services, shared that school districts are required to complete a Federal Grant Application, (referred as a Consolidated District Plan), which outlines components of the Title I, II, IV, Title III Lip Leps, and IDEA Part B Flow Through grants. Funds for SEDOL will no longer be sent to them directly. Discussion was held on if the grants, federal and state funds would be paid.

Reopening Plan

Dr. Anthony Kroll, principal, and Stacey Gorman, assistant principal of teaching and learning, shared that the district reviewed three options for the return to in-person instruction in the fall and/or remote learning.

Ms. Gorman shared what the district learned from the spring semester and that they surveyed parents and students. Board members inquired on support and interventions for students, new students and incoming freshmen. Discussion was held on the topic. She also reviewed the staff and student perspectives, support/academic spaces, transportation, and summer school pilots.

Dr. Kroll shared the next steps and that additional information would be provided at the next regularly scheduled board meeting. He also provided updates on strength and conditioning, band and choir camps, driver's education, Prom, Senior Honors and graduation.

Board president Vogt thanked them for all their efforts during this challenging time.

East and West District Office

Shane McCreery, chief of staff, reviewed the recommendation to move the superintendent, executive assistant to the superintendent, and public information officer to East District Office (D75). He also shared that the assistant superintendent for student services, executive assistant to the assistant superintendent for student services, and the administrative assistant will move to the West District Office. The D75 Mundelein Elementary School Board must approve the renovations to begin the construction.

Final 2019-2020 School Calendar

Mr. McCreery reviewed the final updated 2019-2020 school calendar. The update reflects the recent revisions. The Regional Office of Education and Illinois State Board of Education must approve the final amended calendar.

PRESS Policy #103, Second and Final Reading

Mr. McCreery reviewed the PRESS policy recommendations made by the Illinois Association of School Boards. He shared which policies include language and edit updates. The policies were reviewed by the appropriate administrators for their review and where recommended for adoption.

Textbook Adoption, Second and Final Reading

Dr. Kroll reviewed the second and final reading for the book, *Math Lit. 2nd Edition*. The book was recommended for adoption.
