DISTRICT 120 REPORT

Staffing Proposal for SY2021-2022

Mr. Searle shared a brief update on the budget process that the district utilizes to prepare for the yearly staffing proposal. Dr. Kroll reviewed the staffing proposal for SY2021-2022. Discussion was held on the topic.

2021-2022, Late Start Proposal

Dr. Kroll, MHS principal, reviewed the late start proposal, which included a proposed draft schedule. The proposal included updated arrival and departure times, continued partnership with District 75 bus schedule and other additional changes that may occur. Mr. Pilut, D75 CSMS principal, also reviewed how the proposed drop off and pick up times would adjust for each building in District 75. The next steps would include presenting the proposal to District 75's Board of Education, school community and staff focus groups to define the necessary schedule components. The board members recommended that that they move forward with the proposal.

TRS Supplemental Savings Plan

Mr. Searle provided an overview of the teacher's retirement system (TRS) to provide an optional defined contribution benefit to all its eligible members. The supplemental savings plan will be reviewed by the administration and will be brought back to the board with a recommendation. Discussion was held on the topic.

MHS Liaison Police Services Agreement

Mr. Searle shared that the Village of Mundelein agreed to a four-year agreement to share the salary costs for the School Resource Officer (SRO) position. Discussion was held on the topic.

Hybrid Update

Dr. Myers shared the attendance for students attending the hybrid schedule. He also shared the mitigation survey data and the COVID-19 tracking dashboard. The data shows that students and staff are adhering to the mitigation strategies. Discussion was held on the topic.

Recommendation for a Special Board meeting

Dr. Myers recommended a special board meeting to be held on April 28, 2021. The meeting will be to reorganize and seat the new board members.

New District Policy 7:12, Racial and Education Equity, Second and Final Reading

Board member Yaffe and Mellon recommended the second and final reading for the new district policy be brought back to the April board meeting for further discussion. She also shared that MHS students, Trey Baker and Jordyn Miller will be invited to attend the April 6, 2021 board meeting.

The board discussed the non-renewal confidential position that was pulled from the personnel report listed in the consent agenda. The board members discussed the topic and requested additional information. The topic was tabled.
