DISTRICT 120 REPORT

FY2020-2021 Annual Budget

C. Andrew Searle, chief school business official, inquired if there were any questions related to the annual budget.

Intergovernmental Agreement - COVID19 Relief Fund

Andrew Searle reviewed the recommendation to approve an Intergovernmental Agreement (IGA) with Lake County. Lake County has received federal grant money from the CARES Act. They are requesting the district approve an IGA in order to receive reimbursement for up to \$62,000 in pandemic related expenditures.

PERA Committee

Shane McCreery, chief of staff, stated that the PERA committee is a joint committee of administrators and MEA members that gathers annually to review topics that affect certified staff members. They are currently reviewing how certificated staff will be evaluated this school year and unsatisfactory summative evaluation appeal process. Discussion was held on the topic.

Job Description, Title Change

Shane McCreery reviewed the recommendation to change the job description title to the position of Assistant Principal of Teaching and Learning. The position will be retitled Assistant Superintendent of Teaching and Learning and will report to the superintendent.

Section 4.8, Memorandum of Understanding

Dr. Anthony Kroll, principal, shared that the MEA and administration agreed to a memorandum of understanding regarding section 4.8 pay periods in the 2020-2022 Mundelein Education. Association (MEA) contract. The MOU addressed the changes in athletic seasons as instituted by the Illinois High School Association (IHSA) for the 2020-2021 school year.

Special Education Phase B to In Person

Jamie DiCarlo, assistant superintendent of student services; Kim Goldberg, Michelle Bank and Kandace Terrell, certified staff members; reviewed the special education phase B to in-person program.

They reviewed the goals, planning, 9-12 programming for Phase A, Full Remote, Transition Center-Remote Learning, and sample schedules. The also reviewed the plan for Phase B sample schedules and Specialized Programing for Phase C. They are also in communication with students in public and private therapeutic day schools. They shared that IEP meetings are held via Google Meet, attendance is documented; draft and final copies are emailed, with hard copies being mailed via the United States Post Office. Students can also be brought in-person for testing as needed for case study evaluations. They also reviewed the components created in Embrace IEP and that IRLP does not replace an IEP. IEP's resume when a student returns to 100% in-person instruction. PPE and cleaning procedures and safety protocols in the classrooms were shared. The board reviewed and discussed the recommendations to the special education Phase B plan presented by the district and building administrators. There were questions raised on the plan.

PRESS Policy #105, First Reading

Dr. Kevin Myers, superintendent, reviewed the recommendations presented by IASB PRESS Plus. A second and final reading will be discussed at the October 6, 2020 board meeting.

New District Policy 7:12, Racial and Education Equity Development

Dr. Myers reviewed that the board has been working on equity for the last three years. The development of a new school board policy would address racial equity and support the resolution of safe schools that was previously approved. The two sample school board policies are from two different school districts that address racial equality. Board members Mellon and Yaffe will lead the committee and present their recommendations if a new policy should be developed. The board members also agreed to meet with a student group prior to the next regularly scheduled board meeting.
